Re	Invitation for information meeting on redevelopment of the ANWB grounds		

Dear Mr / Ms ,

You are receiving this letter because you live or work in the vicinity of the ANWB (Automobile Association) premises along Wassenaarseweg 220.

The ANWB has already had its head office along Wassenaarseweg since 1960. In recent years, however, part of the complex lost its use as an office and, as a result, parts of the building are no longer being utilised. Although, as the owner, the ANWB has tried to let these sections, no sustainable solution has been found. The ANWB feels an affiliation with this location, so too from an historical point of view, and has therefore investigated the options to remain in Wassenaar in combination with a partial redevelopment of the grounds.

In conjunction with the ANWB, the municipalities of Wassenaar and The Hague examined under which conditions such redevelopment can be established. In this respect, housing has been discussed as a realistic scenario and the municipality of Wassenaar has drawn up a preliminary memorandum for this, which contains the framework for redevelopment. Prior to any decision-making, we would like to inform you about these frameworks at a meeting on:
